2022 Breeding Contract

For Shipped Semen

This breeding contract for the year 2022 is made on the _____ day of _____ between Raelin Schenck, herein after referred to as "Stallion Owner" and _____ herein after referred to as "Mare Owner."

Mare owner agrees to breed the mare, _____, registration or id number: _____ to the purebred Connemara stallion, Blue Rock Fintan, ACPS S1975 LII.

Approximate breeding date (If known): _____

The conditions are as follows:

1. Mare Owner agrees to pay a stud fee of \$750, which includes a One Year Live Foal Guarantee, and a booking fee of \$250. (Total breeding fee is \$1000.)
2. Booking fee (\$250) is due with the signing of this contract and is nonrefundable.
3. Breeding fee in full must be received by stallion owner prior to ordering semen. Payment can be made via PayPal (blackwingponies@icloud.com), Venmo, or Zelle or by sending a check to Raelin Schenck, 24233 Oalmann Road East, Bush, LA 70431. If payment is made via check, it must be received seven business days prior to ordering semen. Please contact Raelin Schenck via blackwingponies@icloud.com or 985-415-4742 for any additional info.
4. It is highly recommended that all mares have a clean culture and cytology prior to ordering semen.
5. Mare Owner agrees to pay a collection fee of \$275 per collection which must be paid in full prior to ordering semen. (If paying via check, must be received seven days prior to ordering semen.)
6. Collections are made Monday through Friday though not all locations allow for FedEx Saturday delivery. Please check your location prior to ordering semen for Friday collection.

7. Semen must be ordered by noon central time on the day *prior* to collection. Once ordered, semen cannot be canceled and collection fees will not be refunded. If semen is ordered after noon central time on the day prior to collection OR ordered as a same day collection, there is a minimum \$50 rush fee IF the collection can be arranged. This fee must be received prior to collection. Please inform your vet of these details. Call or text Raelin @ 985-415-4742 to order semen.
8. Mare Owner is responsible for all shipping fees. Shipping fees are not included in the breeding fee or collection fee. Stallion Owner is not responsible for delays in shipment delivery or loss of shipment or damage to shipping container or semen. Shipping fees will be paid directly to Stallion Owner's vet on the day of collection.
9. A maximum of four collections per breeding is allowed. If the mare is not confirmed in foal after the first breeding, a uterine culture and cytology must be performed by the Mare Owner's veterinarian prior to request for second shipment of semen.
10. Please keep us updated with the progress of your mare in her cycle. This is greatly appreciated and makes our life much simpler. (Shoot me a text or leave a message- 985-415-4742. You're not bothering me, I promise!)
11. Regular breeding season is February 1st, 2022 through August 15, 2022. We will do exceptions to these dates, however, all exceptions to these dates must be in writing and signed by both parties.
12. The Mare Owner bears all risk of loss or damage to the mare whether through death, disease, injury, infection or otherwise and by any cause whatsoever, including inappropriate, untimely, or negligent inseminations or failure of insemination. The Mare Owner releases Stallion Owner from any liability for any and all associated damages.
13. Live Foal Guarantee (LFG): A live foal is defined as one that stands and nurses without assistance. Should the foal not stand and nurse, the mare owner agrees to notify the stallion owner in writing within one week of the foaling date and furnish a written statement from a licensed veterinarian. The mare owner will be entitled to return the same mare for one rebreed provided the stallion is still standing at stud.
14. If the stallion dies or becomes unfit prior to covering mare (live cover breeding) or the shipment of semen (AI breeding) then this contract shall become null and void and the stud fee, less all other fees, will be refunded.

15. An American Connemara Pony Society "Stallion Service Certificate" will be issued by the stallion owner to the mare owner for the live foal resulting from this mating provided all fees have been paid. All offspring of Blue Rock Fintan, regardless of breed, are eligible for registration through the American Connemara Pony Society. For non purebred Connemara mares, half-bred certificates will be issued by the ACPS (any and all registration fees are due by mare owner).
16. Mare owner understands that stallion is a competition animal and will be unavailable on certain days. However, if you keep us informed of your mare's progress, we will strive to do whatever is necessary to have a collection made, even on a show day, if it is at all feasible to accomplish.

This contract is non-transferable without written permission of the stallion owner. This contract is governed under the laws of the state of Louisiana. This contract represents the entire agreement between stallion owner and mare owner. No other agreements or promises verbal or implied are included unless specifically stated in this written agreement/contract. Once signed, this agreement becomes binding on both parties.
